CSVMC is proud to be part of the new statewide Family Engagement Initiative (FEI), a collaboration between the courts, Children and Youth Services and CSVMC, which seeks to increase family involvement in dependency cases, limit court intervention, and reduce trauma and the time children are separated from their loved ones.

Led by Judge Michael Sholley and Children and Youth Services administrators Matt Ernst (Union County) and Jennifer Evans (Snyder County), Union and Snyder counties have been among the early adopters of the FEI statewide.

Mediators from CSVMC facilitate Rapid Response family meetings, as a proactive early step, designed to give families and their support people space to discuss safety concerns and challenges. They are able to evaluate their needs and develop their own solutions.

"This is an example of collaboration at its best," said CSVMC Board President Bob Shabanowitz. "Every member of the team brings their strengths. CSVMC brings our expertise in supporting difficult conversations. We can help families, who are the experts in their own lives, access their strength and voice



and deepen their connections with one another at a time when they are under incredible stress. That is what our mediators are trained to do."

## Better Angels: Save the Date! February 23

## Join the conversation to bridge political divides



2018 brought us requests from people across the political spectrum wanting help addressing the level and nature of political conflict in our community. People want to know, "How can we deal with the divisiveness?"

In response, we are partnering with the Better Angels organization to sponsor a series of free Red/Blue Workshops. The first session will be held Saturday, February 23 from 11 a.m. - 2 p.m. at 713 Bridge Street in Selinsgrove.

The workshop, which seeks to have equal numbers of red- and blue-leaning participants,

offers the possibility to better understand the experiences and beliefs of those on the other side of the political divide, to identify commonality and differences and learn something that might be helpful to the community. The focus is on listening and reflecting, rather than debating and persuading.

CSVMC Mediator Karen Cotter, a member of Better Angels, said about the program, "At this juncture in our history I feel certain that it's up to us as citizens of the United States to help heal the divide in our nation. I believe that Better Angels is a good resource to help us do just that."

## Lewisburg to use mediation for discrimination complaints

Borough officials have asked CSVMC to play a role in Lewisburg's proposed Human Relations Ordinance, which will include mediation as an early step in the process if there is a discrimination complaint in the Borough.

"Confidential, voluntary mediation has the potential to be transformative in alleged discrimination cases. Mediators are able to create space for these conversations to occur and to support all parties in achieving greater communication, clarity

and perspective-taking," said CSVMC mediator Amy Ershler. Amy is a former volunteer mediator for the Commonwealth of Pennsylvania with experience mediating cases for Pennsylvania's Human Relations Commission.

**2,054** cases have been referred to CSVMC since we opened in 2011.

# Kids First helps separated parents focus on children

Our Kids First program helps parents understand what helps and hurts children, whether parents are newly separated/divorced or are navigating an ongoing co-parenting relationship. Parents learn how they can support their children at all ages and stages of development, and how to reduce conflict and provide a healthy co-parenting environment. This program is designed to provide both important knowledge and hope to parents and caregivers at a stressful time. About 200 adults attended Kids First classes this year.

✓ Define next steps. ✓ Avoid, minimize or enhance involvement of the legal system. ✓ Work toward mutual understanding. ✓ Resolve a specific problem, dispute or underlying conflict. ✓ Prevent problems from recurring.
