Steve Jacobsen, a founding volunteer of the center, described this momentous progress: "We opened our doors for mediations almost exactly four years ago. Enthusiastic and dedicated volunteers turned the dream of our late founder, Al Sobel, into a vital community service. Passing the milestone of having opened 1,000 cases is an affirmation of a lot of hard work and a reminder that creative solutions to community problems exist and that the solutions can be realized by groups of people with the energy and commitment to tackle them."

Steve reminds us to look at this progress as proof that one person's vision can dramatically alter a community, and plant a seed of progress for all. Steve added, "We've had a profound impact on the lives of hundreds of local children and families. All of us associated with CSVMC can be proud of our accomplishment and set our sights on continuing to provide quality services and passing the 2,000 case mark in fewer than another four years."

So far this year, CSVMC's dedicated volunteers have given more than 900 hours to our conflict mediation work in the Susquehanna Valley. The center celebrated its volunteers in May at the home of our board president, Elayne Sobel.

Kids First Program helps parents help kids

In January, the center launched Kids First, a program designed for parents or caregivers going through separation or divorce to help children through the transition by understanding the child's perspective. Based on the work of Chet Muklewicz, Ed.D, the program offers forty years of research done in the area, as well as tips and tools for parents to use to help their children cope through the conflict. Volunteer teachers Benita Kolmen-Solomon, Sharon Silberman, and Amy Gronlund have worked to bring Chet's program to our local community.

As of July 2015, more than 300 people have been referred to the program by Snyder, Union, and Northumberland counties. Party evaluations reflect that most participants learn what helps children and what behaviors and practices should be avoided because they hurt children. Participants report that the program helps them better understand their child's point of view and become clearer about the situation they face. These results reaffirm the faith that the center has in the value of the program and the positive difference it can make. The program supports custody mediation by offering parents additional tools to navigate their conflict.

Moving forward, CSVMC plans to collaborate with other community agencies to bring Kids First to their clientele. In August, teachers will present the program to teen parents from the region who participate in the Project Elect program.
